We, the undersigned taxpaying electors of the District hereinafter described, present this Petition for the organization of a water and sanitation district, pursuant to and in accordance with Chapter 175, Session Law of Colorado, 1939, as amended and reenacted, and in support of this Petition state:

- 1. The name of the proposed District is "Green Mountain Park Water and Sanitation District" in Jefferson County, Colorado.
- 2. The present purpose of the District is to provide a complete waterworks distribution system for the District and the inhabitants thereof.
- 3. A general description of the improvements for supplying water to the District and its inhabitants is the acquisition of the waterworks distribution system of the Green Mountain Water Company.
- 4. The estimated cost of acquiring said improvements is an amount not exceeding \$60,000.
 - 5. The proposed District is described as follows:

Commencing at the Southeast Corner of the Southwest Quarter of Section 15; thence North to the Northeast Corner of the Northwest Quarter of said Section 15; thence West along the North Line of Sections 15, 16 and 17 to the Northwest Corner of the Northwest Quarter of said Section 17; thence South to the Southwest Corner of the Northwest Quarter of said Section 17; thence East to the Southeast Corner of the Northwest Quarter of said Section 17; thence East to the Southeast Quarter of said Section 17; thence South to the Southwest Corner of the Southeast Quarter of said Section 17; thence East along the South Line of Sections 17, 16 and 15 to the Southeast Corner of the Southwest Quarter of Section 15, the point of beginning, all in Township 4 South, Range 69 West of the 6th P. M., in Jefferson County, Colorado.

WHEREFORE, Petitioners pray that this Honorable Court will enter such orders and decrees as may be necessary or proper for the organization of said District, in accordance with law.
